

2023 Texas State Lever Action Rifle Silhouette Championship April 15th and 16th 2023

Hosted by: Austin Rifle Club

Tournament: NRA Registered Smallbore, Pistol Cartridge, and Rifle Cartridge Lever Action Rifle Silhouette matches will be held at the Austin Rifle Club Ranges C, D, & E, near Manor TX on Saturday, April 15th and Sunday, April 16th. This is a TSRA sanctioned State Championship. You MUST BE a TSRA member in good standing to compete in this match. This is an NRA Registered State match.

Rules: Current NRA Lever Action Rifle Silhouette rules will apply, unless otherwise noted...

Eligibility: NRA membership is not required, but recommended. Texas State Rifle Association membership is required. TSRA annual membership is \$40 a year/\$30 a year for seniors (\$5 for juniors).

Classification: NRA Silhouette Classification System/fees apply to all matches and contestants. Please pay your \$15 NRA fee at least 30 days prior to the match, so current classifications can be verified. Any entry that cannot be verified will participate as a Master class contestant in that match.

Safety: Empty chamber indicators will be required per Rule 3.21. If you do not have a suitable indicator, one will be available for purchase for \$1.00 at registration. All rifles, unless in a carrying case, must display an empty chamber indicator in the action when not in use. All rifles must be carried actions opened and racked with the muzzle up. Hearing and eye protection will be required on the firing line. Absolutely no handling of firearms while anyone is downrange or forward of the firing line.

Alcoholic beverages will not be permitted on the ranges. Any competitor consuming alcoholic beverages before or during the match will be disqualified from the event.

Squadding: Squadding will be arranged so that all competitors will have a spotter/score keeper. Requests for squadding, sharing equipment, spotting, etc., will be accommodated as best as possible. These requests are on a first come first serve basis and need to be included with pre-registration.

Target Setting: Target setters will be provided.

Entry Limits: Entries will be limited to 96 participants for SBCR and PCLA, **48*** for Rifle Cartridge Lever Action Match.

Entry Fees: Entry fees will be: \$40 per match/qun or \$110 to shoot all 3 matches, if registered & paid before March 15st.

Junior entry fees: \$20 per match/gun or \$50 to shoot all 3 matches, if registered & paid before March 15st. Entries received after March 15st will be assessed a \$20 late fee and squadding will be done "as available"

Registration: If submitting an entry form via email, the fees charged should be mailed to the above P.O. Box

address. Hard copy entry forms can also be mailed to the match stat officer at the above address.

Please note the discounted entry fee for submitting your entry before March 15st.

* Entries to Sunday's Rifle Cartridge match will be limited to a maximum of 48 and are on a 1st come, 1st served, entry date received basis. Any entries beyond that limit of 48 will be placed on a waitlist.

Lunch will be provided for competitors. Any additional lunches can be purchased for \$10.00.

Awards: Minimum for each rifle (PCLA, SBLA, Rifle LA):

Match Winner

1st in each class*

2nd in each class

3rd in each class**

Types of awards: Awards other than High Overall in each gun, Aggregate State Champion, and Special Aggregate awards may be cash. Governor's Twenty Pins will be awarded.

Scoring: Competitors will be required keep score for each other. Competitors are required to examine scorecards after each series and to initial cards before leaving the line. Any scoring discrepancies must be resolved at the end of the shot series involved and before targets are re-set. If a scorecard is signed without correction, the recorded score will stand and no changes will be made.

Jury: A jury of three persons will be selected and will act as the final authority of protests and disputes involving procedures, equipment, or any other grievance filed.

Equipment: Rifles must be certified and meet NRA specifications. All rifles will be certified prior to the start of the event. No non-certified rifles will be allowed on the firing line. Rifle may be re-inspected by the match director, safety officer, or jury at any time during the duration of the match. Only clothing appropriate for existing weather will be permitted. Properly fitting shotgun style vests will be allowed, however leather shooting vests or jackets will not.

Long Runs: Long runs will be fired at the end of each day after the conclusion of shoot-offs. Intent to shoot a long run attempt must be declared prior to the awards presentation each day.

Team Entry: The Team Match is open to three-person teams complying with rules 2.10, 2.11, and 2.12 with classification determined by rule 19.12. Team entries must be made prior to the first shots of the match. Team scores will be the combined aggregate scores for all team members. Team entries will be free and accepted only at the match. Team scores will be for National Records and a hardy handshake only.

In-A-Row Pins: 5, 10 and 15 In-a-row pins will be awarded upon request.

Ties: Ties of individual matches will be decided by reverse animal count except for Match Winner. Ties that cannot be decided by reverse animal count will be decided by sudden death shoot off. Ties for Match Winner and Aggregate Championship will be decided by five shot shoot off on the appropriate target as determined by the Match Director.
