**Entry Fees:** \$75 for first rifle, \$25 for second rifle, third rifle is free. Juniors shoot one, two or three rifles for \$50 total.

**Awards:** The following will be awarded for each rifle (Lever Action, Pistol Cartridge & Smallbore):

State Champion Match Winner

First in each class

Second in each class

(\*\*classes with fewer than three shooters may be combined with the immediately higher class\*\*)

The following will be awarded for the three-match aggregate:

Grand Aggregate State Champion (aggregate for all matches)

High Woman

High Senior

High Junior

**Teams:** Teams will be considered for national records with 1<sup>st</sup> and 2<sup>nd</sup> place awards for teams. Teams will register on Saturday morning.

**Ties:** Ties for the individual matches will be decided by reverse animal count. The aggregate for overall champion and classes will be decided by shoot-offs following the last match of the day.

**Targets:** Smallbore and pistol cartridge targets will be half-scale targets set at 40 meters (chickens), 60 meters (pigs), 77 meters (turkeys) and 100 meters (rams). Big bore targets will be full-scale targets set at 50 meters (chickens) 100 meters (pigs), 150 meters (turkeys) and 200 meters (rams)

\*Please Note that loads that damage targets will not be tolerated.

**Target Color:** all targets will be painted black. Single loading single loading of any writing will be allowed. The cartridge will not be required to be loaded from the tube of the rifle.

**Side Matches:** There will be side matches Saturday after the match. Sign up sheet will be available at time of check in.
